#### Minutes from Church Council Meeting March 7, 2022

Call to Order at 6:31 by Moderator, Charley Freeman

Devotions – Portia Freeman shared the message of enjoying today what we receive, to turn small moments into occasions, so that we may enjoy with serenity in our "time left" and not wait until "sometime later", after health passes, promises are forgotten, moments are past.

Minutes of previous meeting — Charley requested that Council Members read the agenda of the current meeting and minutes of the previous meeting that are distributed before each meeting in an effort to assure informed discussion and efficient conduct of business. The Church Clerk had previously distributed the minutes of the Feb 7 meeting. Marilyn reported that she had advised Clerk of needed correction: addition of activity and current balance of the Benevolence Fund, and she then moved to accept corrected minutes. Joe seconded; motion approved. The Clerk is to distribute corrected minutes.

Pete raised the question of Item 4.06 Snow Removal: was this for plowing blizzard peak? Reply that there has been more than one plowing and higher cost if more than certain depth. More bills are expected from contracted service provider: Mikey B's Lawn Care, Stonington. Patti moved to accept Treasurer's Report; Li Ling 2nd.

#### Deacons

#### **Building and Grounds -**

Richard Tourjee reported a number of things he has noticed that need attention:

- -fix gravel parking lot: manual labor raking stones that have been exposed by snow plowing -church parking lot: asphalt repair in multiple places
- -parsonage roof needs to be replaced dry, pieces noticed on ground; thinks 25-30 years old, done previously by Irving and Jon Hiller; new roof will be more costly and more involved as it was laid over multiple old layers
- basement window of parsonage repair if possible or replaced if needed; some wood rotted Windows of parsonage some frames and windows need scraping, putty, paint Front door of church is not closing properly (way two doors come together)

Side door of church at ramp - scraping and painting

Windows in balcony need to be reputtied - on inside and outside; one was worked on last year but not sufficient

Marilyn suggested make list public so congregants can step up in providing labor and /or materials.

Charley asked that Drew develop list and follow up on suggestion that it be made public. Richard suggested that Drew compile a list of persons as sub-committeee to do the work. Joe reported that a parishioner has asked about lighting on the parking lot, ramp side area. Charley noted that front spot lights are thought to serve that side; perhaps they need to be evaluated for reach distance and adjustment.

Drew acknowledged list and idea of compilation of names to do various jobs.

#### Finance and Stewardship -

Patti reports account balances of \$5418.21 in Ameriprise and of \$4909.13 in American Baptist Extension Corporation (ABEC). She has been notified that ABEC account has matured (5 years) and will roll over automatically. She needs to provide verification from meeting minutes that she is authorized to send back documentation as signatory to renew ABEC contract. She suggests that other person be added to serve as back-up. Marilyn suggests that name authorization cover more than this activity. There was discussion on how to word, including details in previous paperwork and wording to reflect that names are changed with change of deacons in new year.

Patti moved that deacon of Finance & Stewardship, Patti Tootell or Deacon of Benevolence, Marilyn Rodearmel, are both authorized to sign individually as legal representative for Ameriprise and ABEC contract. Drew seconded. Approved.

It was decided that meeting minutes not be provided to ABEC, but Carol to write up in letter.

Richard - as nominating committee, has asked Sandy Vocolina to accept position vacated by death of Sarah Adams; Sandy accepted but requests a few months to get beyond current family issues.

#### Old Business -

Financial Secretary Backup; Treasurer Backup-

Charley requested suggestions, noting that Moderator is signer on accounts unless you want to change that, and that back up needs to be available to sign checks. It was suggested that backups for Treasurer be Mei Ling and Patti Tootell. Marilyn Rodearmel volunteered to be backup for Financial Secretary, with agreement by Pete. Richard moved that proposed backups for both positions be accepted; LiLing seconded. Approved unanimously.

Electronic Voting-

Discussion: Marilyn said would like to be able to vote electronically, as it has come up several times. Joe described his research: not included in PBBC Constitution and Bylaws; Robert's Rules of Order (RRO) is not specific but says each institution comes up with verbiage to include in bylaws, making distinction between voting and meeting. RRO mentions a "deliberative assembly," so can identify what is being said, by whom, eg., like current meeting or otherwise interactive. Zoom works as "deliberative assembly". Voting as secret ballots would require specific verbiage in bylaws. Charley notes that the person who sets up Zoom meeting must deliberately authorize attendees and that we are not set up with logistics to function by Zoom. Discussion continued: question if could be done without changing Bylaws but by response to Clerk as has been done for consensus to lower rental property, should begin with change of by-laws and that anyone can initiate, requires approval by portion of congregation who have been given 30-day notice, per Constitution and Bylaws. Dianne acknowledged Joe's research and reporting efforts to comply with business rules and that others on council had been tasked with this and it was not brought to fruition. She volunteered to work with Joe, that even though there is no specific urgency it is better to do sooner than later, i.e., before summer.

#### Other old business:

Joe reminded that Annual Meeting minutes were previously distributed and asked if corrections/additions. None raised.

#### New Business -

Organ Maintenance

Charley reports that when he first took Moderator position he got letter offering services to tune organ by new person who had been given PBBC name by prior organ tuner. (See attached document reporting conversation with McNeely Organ Co.) He thinks appropriate to make responsibility of Building & Grounds. Charley has recently signed a contract w/ McNeely Organ Co. Richard moved that new organ contractor be hired to paint and repair the pipes per the \$500 estimate, with provision that we provide manual labor to lift, remove and replace pipes. Discussion: Painting is by mix w/ brass shavings. This provides nice completion of prior work in sanctuary of ceiling and walls. Marilyn suggested this is something to be brought before congregation for help and contributions. Charley said that it will need to be done when weather is good, thinking May or June, to be able to take the pipes into parking lot for painting. Drew seconded. No further discussion. Approved unanimously.

Patti announced that she has been in contact with Holly B who has items for children so they will have an Easter Egg hunt on church lawn area on Easter Sunday.

#### Additional Business - none raised

Adjourned at 7:42 - as moved by Marilyn, seconded by Li Ling and approved unanimously.
