

CHURCH COUNCIL MEETING Minutes January 9, 2023

Call to Order - Charley at 6:32

Devotions – Portia read a comparison of accidents in the home, work, on roads, etc as compared to low incidence of 0.001% at church, so for safety's sake we should attend church and Bible Study.

Minutes of previous meeting – Church Clerk Carol Gatlin Marilyn moved and Joe seconded to accept minutes as distributed by email; approved.

Pastor Claudine expressed gratitude for Advent, Christmas and Epiphany seasons. She will be on vacation Jan 16-30. Heidi Butler will preach on Jan 22 and Rev. Jonathan Scott on Jan 29. The committee is close to ordering selected new hymnal "Glory to God", expecting to purchase 85-90, with tentative dedication in mid-May. She will coordinate with Cathy G for use of vestry for baby shower for Megan and Jeff Wilbur on Feb. 4.

This Sunday is the SUNL Association Annual Meeting; she will be attending, along with delegates Charley and Portia Freeman, and also Becky Freeman. Our dues have been paid.

ABCCONN 200-year Regional Anniversary will be recognized in a prayer event on Jan 20 at 3:30 and a worship event on Apr 30.

Having met with the ABCCONN Commission on the Ministry and having met all the requirements for Ordination under our regional guidelines, our SUNL Assoc has been asked to call for an Ordination Council related to Heidi Butler. PBBC will host this event on Sunday, Feb 19 at 3:00 pm (snow date Feb 26). Each congregation is allowed 3 voting delegates (pastor and 2 lay delegates) but all are welcome to attend. This is an opportunity to hear Heidi's Ordination Paper and participate in the question/ answer process. We need a quorum of 7 churches in order to proceed. If the vote is favorable, we will be instructed to plan a Service of Ordination. Tentative plans are being made for the last weekend in May (May 28 is Day of Pentecost) for PBBC to host a celebration with reception, either on Saturday or Sunday afternoon. Instead of purchasing a new preaching robe as a gift from the church, Pat Tootell is working to make alterations to the Rev. Kevin Butler's robe as a gift to Heidi and has made an ordination stole to present that day. We should reimburse any expenses. She has given Jon Hiller a list of 8 names for the Memorial Board (completing another frame) on the back wall of the sanctuary: Sarah Adams, Patricia Boulez, Bob Bogue, Rev. Kevin Butler, Rev. Dick Strong, Lucie MacArthur, George Allen Jr., Bobbie Allen. This will be Jon's outgoing task as Memorial Fund Treasurer.

Ash Wednesday is Feb 22 and she would like to return to Bread and Broth gatherings.

Carol asked about Catherine Hespeler's name on the Memorial Board; her name will be added to a new frame. Richard asked about her taking sabbatical; if she takes in 2023 it will likely be in the Fall. Drew asked what will be done with the old hymnals; she will reach out to other churches in SUNL. Marilyn suggested offering to prison system; Richard suggested offering to congregation.

Deacons -

Worship and Membership – Portia Freeman/Peg Straub Portia said the report has been submitted for the Annual Report.

Building and Grounds – Drew Wesche/Holly Boyle Drew said the report has been submitted for the Annual Report. Holly said cleaning of furnaces on all (3) properties has been scheduled for Feb 22.

Stewardship/Benevolence – Patti Tootell/Marilyn Rodearmel Patti reported Memorial Fund balance of \$30376.88. She has not called ABEC this month for specific monies but the balance should be a little more than last month.

Marilyn reported starting balance of \$702.95 with outstanding check for \$100, written and sent the end of November but not cashed; Pastor Claudine will follow-up with known contact.

Ed Boyle has been appointed Memorial Fund Treasurer, replacing Jon Hiller. There was discussion as to back-up person for Memorial Fund Treasurer, asking Jon Hiller to stay as back up and his status and that of Betty Land as named persons on file with Chelsea Groton Bank. Carol to contact each of them. Discussion evolved to having back-up to Richard Tourjee, Jr as Mission Fund Treasurer, identification of this person from Council or congregation, and duration of term. Richard Sr moved and Holly seconded to identify a back-up for Mission Fund Treasurer; approved by vote. Holly moved to name Dianne Augeri; Marilyn seconded. Dianne accepted the nomination. Approved.

Education and Discipleship - Joe Greene -

Joe reports that Sunday School classes will resume this Sunday, Jan 15.

Mission and Outreach - Dianne Augeri/Li Ling Liu -

Dianne reports that report for 2022 has been submitted to Barbara. Giving was good last year. Donations to RMMO are still be accepted; really donations to any mission will be accepted at any time. They will announce World Mission Offering this Sunday, moving this campaign from Fall because of numerous financial solicitations at that time.

Pastoral Relations - Sue Shontell -

Sue reports that report for 2022 has been submitted to Barbara. PRC will meet during Q1 2023 with new delegates.

Hospitality and Special Events - Cathy Greenfield/Sandy Vocolina Cathy said nothing to report. Charley thanked for hard work over the past year with routine Sundays and special events.

Nominating Committee - Richard Tourjee -

Richard reported that nominations are settled for next year except for Hospitality. Holly suggested allow Cathy stay if willing; Cathy declined. There was agreement of need to fill this deacon position; suggested add to announcements to congregation.

Marilyn requested listing of replacements; Richard detailed:

Hospitality: Sandy Vocolina

It was noted that Patti has completed 2 years + 2-year extension as Deacon of Finance, thus position needs to be filled. Discussion ensued, with review of Bylaws, as to Deacon of Finance and Deacon of Stewardship as separate and unique positions, too demanding to be filled by one person, that Stewardship description names Benevolence (offering).

So, we are without a Deacon of Finance and a (second) Deacon of Hospitality. Unless these positions are filled first ie., by request or volunteer, announcement request for volunteers will be made at Annual Congregation Meeting in Feb.

Old Business –

- Agenda for Congregation meeting to be held Feb 5, 2023 to include proposed ByLaws change re: electronic voting and open Deacon positions.
- -Volunteers needed for cleaning in Janet's absence Jan 13, 20 and 27. Marilyn and Portia volunteered.
- -Status of updating Groton Chelsea bank account signatories. (NB local bank facility is closed until "mid-February" due to water main break). To be finalized after Deacon slate is approved at Annual Congregation Meeting.

8. New Business -

2023 signup for Devotions - to be routed next month
Jonathan said that per usual online login to Chelsea Groton account
there was a new checking account line with \$622 and asked recognition of amount. Marilyn replied that it looks like Benevolence Fund
balance, and bank must have put this account under the church's after she spoke with them in October.

Additional Business –

Barbara has asked about re-activating rotational role of Greeter at both sanctuary doors on Sunday mornings. Greeting is happening in general; a volunteer for scooter assistance at the ramp door is happening per sign-up sheet. Discussion about considering COVID. Pastor Claudine said could re-activate in more organized way with sign-up/rotation, wearing masks.
